Students must be between 15 and 22 years of age. Permitted drivers must have a minimum of 2 months experience. Licensed drivers, or a driver who has lost their license are accepted with current insurance.

A **Certificate of Completion** will be provided upon the successful completion of class. Students should keep a copy of the certificate for their records and deliver a copy of the certificate to the court.

- Have your vehicle inspected by **any** certified mechanic using the Car Safety Inspection Form. A list of shops has been provided for your convenience on the inspection form. These shops have agreed to perform a **free inspection** on a space available basis. Paying customers have priority, so please make an appointment.
    - If the car does not pass inspection because repairs or maintenance are needed, you **MUST** get the repairs made in order to use the vehicle in class. Repairs do not have to be made by the shop performing the inspection. Submit copies of the repair receipt with the Car Safety Inspection Form.
    - If you do not agree with recommendations made by a shop, you are free to take your car to any certified mechanic for a new inspection. You will need to print a new inspection form. Altered inspection forms are not accepted.
    - A passing Car Safety Inspection Form is required to complete your registration.
  - Complete the Class Registration Form, obtain appropriate signatures on the Waiver of Liability and Release and make a copy of your current proof of insurance card.
  - Submit the Car Safety Inspection Form, Class Registration Form, Waiver of Liability and Proof of Insurance no later than the Monday prior to your scheduled class. Use any of the following methods:**

## Crash Avoidance Teen Driving Skills

This class provides young drivers with “behind-the-wheel experience” to develop various car control and defensive driving skills. Classes are conducted on a closed course in the student’s personal vehicle. Specific areas of emphasis include:

**Threshold Braking** - braking at the threshold of lock-up while avoiding a skid or spin.

**Crash Avoidance** - maintaining control of the vehicle while maneuvering out of harm’s way.

**Skid Control & Recovery** - maneuvering & braking on icy, snowy or slippery surfaces and skid/spin recovery.

**Backing** - developing comfort and control in backing and maneuvering in confined spaces.

**Defensive Driving** - encouraging the consistent use of defensive techniques such as: “Hand-to-Hand Feed”, “Aim-High Vision Technique”, and proper hand positioning for quick reaction and controlled steering

**Distracted/Impaired Driving** - observing the negative impact of distracted/impaired driving.

**NOT ALL VEHICLES ARE SUITABLE FOR THE CRASH AVOIDANCE TEEN DRIVING SKILLS CLASS.**

**These vehicles may not be used!**

Any year Ford Bronco II

Any year Jeep CJ-5 (CJ-7’s & Wranglers are ok)

Any year Suzuki Samurai or other similar type of short wheel-based SUV with a high center of gravity.

Any year, any make full size van and pick-up trucks larger than ½ ton.

Any year, any make vehicle with after-market modifications that no longer meets factory specifications.

Any year, any make vehicle with studded snow tires.

**SOME CARS HAVE REDUCED FUNCTIONALITY ON THE SKID-PAD:**

**Please use a different vehicle, if possible!**

Any vehicle with a government roll-over rating of less than 4, will be evaluated by an instructor and may not be allowed on the skid pad, please check your car on this website: <http://www.safercar.gov>

**INSTRUCTOR DEMONSTRATIONS ARE A VALUABLE TEACHING TECHNIQUE.**

Instructors may drive a student vehicle to demonstrate proper technique to your student. On occasion, a student vehicle may be driven by an instructor to demonstrate skills to other student passengers. Please notify the instructor if you do not want your vehicle used for student demonstration.

In the event of **BAD WEATHER**, we will call you at the home number on your registration form. Classes are rarely cancelled due to inclement weather. Please call (303) 805-0228 on Monday to reschedule.

### “DAY BEFORE” CHECKLIST

**What to wear/bring on the day of class:**

Tennis shoes or any flat soled shoes (no open toe shoes or sandals)

Weather appropriate jacket when necessary

Sunglasses, sunscreen

Snacks and sack lunch (students cannot leave the area during lunch break)

**No cell phones are allowed during class!**

**What to check on your car:**

Check fluid levels (oil, coolant, transmission)

Add 3-4 additional pounds of pressure to tires just before class (to improve performance on skid pad)

Check for working brake lights

Remove all loose items from the inside & trunk of car and remove anything hanging from mirror

Gas tank should be at least ¾ full



**If you miss or arrive late for your class, YOU FORFEIT YOUR REGISTRATION FEE. To sign up for another class you must repay the full fee.**



**If you wish to reschedule a class, you must contact us more than 5 days prior to your scheduled class. There is a \$25.00 charge to reschedule a class. To reschedule less than 5 days prior to class you must repay the full fee.**



**There is a \$25 returned check fee.**

## WAIVER OF LIABILITY AND RELEASE AGREEMENT

The undersigned hereby acknowledges his or her understanding that there are risks inherent in the process of learning to drive and in driving a vehicle. Although South Metro Safety Foundation, South Metro Fire Rescue Authority, and the Town of Parker (collectively "Sponsors") have taken every precaution to minimize such risks and to maximize student and instructor safety; some risks remain, and cannot be controlled by the Sponsors.

In consideration of attendance at, or participation in, the Crash Avoidance Skills Training Clinic ("CASTC") taught by program sponsors, I hereby agree as follows:

1. I hereby knowingly and voluntarily release, discharge, and waive forever any and all liability on the part of, and covenant not to sue or institute any claim against the Sponsors, instructors, insurers, lessors, property owners, or any agents, successors, or assigns of any Sponsor, resulting from or arising out of or in connection with my child's attendance at or participation in a CASTC. I further agree to indemnify and hold harmless the aforementioned Sponsors from any and all claims, demands or causes of action, which allege negligent acts of omissions, unless such negligent acts of omissions are found by a court of law to constitute willful, wanton, or gross negligence.
2. I warrant and represent that I personally and my vehicle are fully insured and will continue to be fully insured in accordance with Colorado law, and in addition, that I have both personal liability and property damage coverage which is adequate to cover any exposure to me, my child, my vehicle, or the property or person of others arising from participation in the CASTC program, during the period of my child's participation in the CASTC program.
3. I hereby acknowledge that the development of driving skills entails known and unanticipated risks which could result in physical and/or injury to my child and/or third parties, or damage to my property and/or the property of others. I understand that while every effort is made to reduce risks, such risks can simply not be eliminated without jeopardizing the essential elements of this type of driving skills course.
4. I hereby knowingly and voluntarily assume full responsibility for the risk of bodily or emotional injury, death, or property damage incurred by me and/or my child, as a result of participating in the CASTC program including classroom and parking lot activities. It is understood that the Sponsors will not accept responsibility for the actions, and/or mistakes of any participant. Participant's attendance is voluntary, and he or she elects to participate in spite of the inherent risks.
5. Should the Sponsors or anyone acting on their behalf, be required to incur attorney's fees and costs to enforce this Waiver of Liability and Release Agreement (the "Agreement"). Participant agrees to indemnify the Sponsors for all such fees and costs.
6. This Agreement shall be binding upon me and my personal representatives, assigns, heirs, and next of kin. By signing this Agreement, I acknowledge that if I or my child is injured or if my property is damaged during my child's participation in this training; that I have waived any rights to maintain a lawsuit against the Sponsors, their agents, successors, and assigns.
